

Hi Andrea Hartmann-Piraudeau, You've received a new 5 star review from Imke Wulfmeyer!

Here is the review content:

This Feedback Digest is based on three feedback forms from different mediations taking place between 2018 and 2019.

Dr. Hartmann-Piraudeau has been rated at Performance Level 5 by all parties for whom she has acted as a mediator. Without exception, the parties would recommend Dr. Hartmann-Piraudeau as a mediator. Likewise, all parties who experienced her as a mediator would be willing to appoint her again. The costs of the mediation were generally reported as reasonable. An outstandingly high degree of satisfaction was reported by all parties. There have not been any negative comments concerning her performance as a mediator. All of the described mediations resulted in a resolution that was considered mutually beneficial by the parties involved.

All parties perceived Dr. Hartmann-Piraudeau as a very helpful and competent mediator.

She guided the parties through the mediation process with confidence and never seemed entangled in the conflict. The balance between the parties' own contributions and impulses from her side was emphasized as particularly pleasant. Her ability to

concentrate and her quick reaction to the verbal and non-verbal communication of the

parties was highly praised.

Her warm and at the same time sensitive manner was especially emphasized. She

succeeded in meeting all people with empathy without ever giving up the necessary

professional distance. The parties were impressed by the ease with which she

established good contact with all parties to the conflict. She conveyed the feeling of

acceptance to all parties involved and created space for the joint development of a

solution.

Dr. Hartmann-Piraudeau was highly appreciated for successfully mediating conflicts in

larger groups, such as an inheritance dispute between various family members or a

controversial teambuilding process involving about 20 people.

The parties emphasized that Dr. Hartmann-Piraudeau left plenty of room for emotions

as well as for solutions. She succeeded in ensuring a safe environment with mutual

respect among the parties. This way, the parties reportedly felt encouraged to be very

open with their feelings.

Dr. Hartmann-Piraudeau's intercultural competence was hailed as a key strength. Her

ability to respond to different cultural backgrounds in a sensitive and respectful manner

obviously enabled her to create mutual understanding for the cultural divergence of an

international project team.
