INTERNATIONAL ACADEMY OF MEDIATORS MEMBERSHIP CRITERIA

Overview

New IAM members will be admitted to membership in the Academy under the following guidelines:

- Membership is by invitation only
- Membership is limited to **professional commercial mediators** who are **well established and recognized** in their local or regional community as **leading mediators** in the field
- The IAM is dedicated to inclusiveness and diversity across a full spectrum
- The Membership and Recruiting Committees assist Academy members in identifying mediators who meet the criteria for invitation by the Board of Governors to join as **Distinguished Fellows**

Criteria for Admission to Membership as Distinguished Fellow

Nominees for membership in the Academy in the **Distinguished Fellow** category must generally meet the following *minimum* qualifications with respect to mediation experience:

- in commercial mediation practice at least **5 years**, with corresponding certification for those mediators who practice in jurisdictions that have certifications for commercial mediation
- at least **a majority of their professional efforts** are dedicated to commercial mediation
- in developed markets, must have worked at least 300 600 commercial mediation days
- in emerging markets¹, must have worked at least **150-300 commercial mediation days**
- in undeveloped markets², must have worked at least **50-100 commercial mediation days**
- mediation days consist of at least 4 hours of work focused on mediation of commercial disputes (including teaching, training or facilitating as well as mediating disputes and excluding days spent mediating pro bono, small claims and domestic relations matters)
- alternative mediator experience may be considered provided it is substantially equivalent (participation in mediations as party or counsel is not considered mediator experience)

¹ "Emerging" markets are those areas or regions where relatively fewer commercial disputes are mediated, in contrast with developed markets where the majority of commercial disputes get referred to mediation, whether by courts, counsel or parties. Factors include: the extent to which mediation is mandatory, the length of time mediation has been in use, the types of disputes that go to mediation and the numbers of mediators who practice on a full or substantial-time basis.

² "Undeveloped" markets are those areas or regions where mediation is just beginning to be utilized and thus very few commercial disputes are mediated and very few mediators practice on a full or substantial-time basis.

Prof. Andrew Goodman LL.B., MBA, PhD, FCIArb, FInstCPD, FRSA, Barrister, CEDR Mediator, IMI mediation advocate, Bar, Inner Temple, International Advocacy Training Council and Nottingham Law School advocacy trainer and international consultant in conflict avoidance and management, and dispute strategy.

Prof. Andrew Goodman practises at **1 Chancery Lane, London** and is a Master of the Bench of Inner Temple. He has been an arbitrator since 1988, a CEDR mediator since 1993 and travels internationally in that capacity and as a mediation advocate, trainer, advisor and consultant to governments, judiciaries, Bars and companies. Andrew is widely recognized as a thought leader in the field of mediation. He is Convenor of the Standing Conference of Mediation Advocates, Director of the Association of Mediation Assessors, Trainers and Instructors and a member of the Bar ADR Panel, the Independent Standards Commission of the International Mediation Institute and Co-Chair of the IMI Mediation Advocacy Appraisal Sub-Committee. He is currently a visiting mediation and dispute management trainer to the Hong Kong, Nepal, Delhi, Istanbul, Ankara, Antalya and Izmir Bar Associations and the Judicial Academy of the Nepal Supreme Court, the Nepal International ADR Centre, the Thailand Arbitration Centre, and the Lagos Multi-Door Courthouse. He is an advisor on mediation to the Turkish Ministry of Justice, the Turkish Court of Cassation and the High Council of Justice in Brussels.

Andrew is a Faculty trainer for the Chartered Institute of Arbitrators and ADR Group, (UK), the Joint Mainland-Hong Kong Mediation Center, the Indian Institute of Arbitration and Mediation, and an ABTA ArbEx panel arbitrator and conciliator.

His areas of professional practice extend to commercial, property, construction, oil and gas, partnership, franchising, professional negligence and farming disputes. He has mediated several hundred mediations – valued variously from non-monetary settlements to \$800m - and been recommended as a leading junior in professional indemnity work and mediation in the *Legal 500* for 23 years (qualifying for the *Legal 500 'Hall of Fame'*) and for four years was listed in *Chambers Directory* as a leading practitioner is ADR. He is currently Professor of Conflict Management and Dispute Resolution Studies at Rushmore University, a sometime visiting lecturer on the LLM/MA courses in Dispute Resolution at UCL and SOAS, University of London, and a peripatetic lecturer in mediation at a number of other UK universities; he is a visiting lecturer in arbitration and mediation at the Dubai Real Estate Institute, a guest lecturer to the University of Ghent LLM Alumni Association and a sessional lecturer at Mandela Institute, University of the Witwatersrand.

Between 2007-2010 he was Director of Mediation Training for the Royal Institution of Chartered Surveyors and led the CMC approved RICS mediator training courses in the UK and abroad until 2013. He was a guest lecturer on ADR for the Lord Chancellor's Visiting Chinese Lawyers' Fellowship Programme and has trained in mediation and conflict management and contracts management in the UAE, Kuwait, Oman, Nigeria, Turkey, Hong Kong, Malaysia, the Netherlands, Nepal, Thailand, India, Poland, Germany, France and Belgium; he advises governments, judiciaries and NGOs on mediation advocacy in Belgium,

Croatia, Nigeria, Ghana, India, Singapore, Thailand and the People's Republic of China. He speaks widely on the subject both on an in-house and open basis.

Andrew is a senior mediator at the Joint Mainland-Hong Kong Mediation Centre; the Nepal International ADR Centre; the A+ ADR Centre, Ankara, Oakwell Mediation Centre; Lagos, an IIAM Delhi panel mediator; and panel mediator at the Thailand Arbitration Centre; he is a Senior International Mediation Expert (SIME) of the International Dispute Resolution & Risk Management Institute (PRC). He is an ABTA Travel Dispute Arbitrator, an ADR Group Accredited Online Mediator, and an ADR Group mediator assessor. He is a trainer for and member of the Board of Advisers of PracticeForte Pte. Singapore.

Andrew is also a partner in the full service law practice of Weinbrot, Chimicles, Shub and Goodman LLC, Washington D.C., USA. He is active in class and collective actions and group litigation and is Director of Gateway Class Actions Limited.

He is the author and editor of nearly 50 books and 12 journals including *Preparing for Mediation – A Guide for Consumers* (Mediation Publishing 2015) *Effective Mediation Advocacy – A Guide for Practitioners* (3rd edn Mediation Publishing 2016 with practitioner and student editions in the UK and dedicated editions in Hong Kong, Nigeria, Turkey (Turkish language) and India); the contributor of the chapter on Evaluative Mediation in *Mastering Commercial Mediation* Richbell and Others (Bloomsbury 2014) and the chapter on Nepal to the *Asia Mediation Handbook* (Thomson Sweet & Maxwell HK 2015); author of *How Judges Decide Cases: Reading, Writing and Analyzing Judgments* (2nd edn Wildys 2018), *Effective Written Advocacy in Practice* (2nd edn Wildys 2011), although he is most well-known as author of *The Court Guide* (20th edn PP Publishing 2011-12).


