Thanks so much, Ben, for providing additional detail about a terrific candidate, and for recruiting her to IAM where we fully expect she will be a valued contributor for many years to come.

Given that the issue of "mediation equivalent" experience while serving as a judge arises on occasion, I thought it might be helpful for future reference to list the "tests" that were so helpful in Lisa's case:

- 1) Mediation Test identifying with specificity the type of work, and skills involved, while serving as a judicial mediator, including, the critical distinction between presiding over settlement conferences as the trial judge and assisting other judges with attempting to mediate their cases
- 2) Market Test checking references carefully to ascertain the nature of the judicial experience (in Lisa's case, her references confirmed that they admired her mediation skills and work since before she entered private practice and that they have in effect been "clients" for many years)
- 3) Test of Time some period of time in private practice (say 12 to 18 months) provides a measure of the continuity of the mediation practice (in Lisa's case, her practice took off right from the start because she already had built up a mediator reputation while still on the bench).

I have been a full time mediator for well over 30 years. Because I helped develop mediation in my part of the world (was one of two in Phila when I started and wrote the ABA's first book on mediation practice fir business disputes) I have had well over 100

persons turn to me for advice on developing a mediation practice over the years.

I can say than none impressed me more than Lisa Rau. Unlike most judges, Lisa understood that resolving disputes are as much about the people and the problem as the positions attorneys want to argue in court.

Lisa's was and continues to be passionate about the process and committed to learning as much as she could in a very short period of time. Advanced courses at Pepperdine, education and training at CPR and the ABA are just a few of the venues Lisa turned to. In the past year and a half she has given many lectures and programs including the one major mediation program in Phila each year which she chaired this year.

Lisa is now considered among the best in our region (now populated with over 500 part and full time mediators). Her schedule is completely full and she plays to great reviews.

Lisa's consummate desire to learn more continues as she now writes, lectures, and continues to learn. Her passion for the process continues and she has attended most of the IAM's virtual programs this past year.

Hello Jeff and Steve:

I am attaching Lisa Rau's Nomination package, complete with references. I am her sponsor and Ben Picker is her co-sponsor.

I have been discussing this Nomination with Lisa for over 6 months now. In brief, Lisa was a judge in the Pennsylvania state court system for about 20 years. Her role evolved from regular trial judge, to "team leader" with responsibility for trial assignments to essentially full-time mediator. As Lisa put it in one discussion with me, she decided to leave the bench to become a full-time mediator because that is what she was doing anyway, just working for the state instead of her own private practice.

The question with Lisa's Nomination is not whether she is an elite mediator (she clearly is), but to what extent we can give her credit for her experience while mediating as a judge. She explained in an addendum to her Nomination form the distinction between what she did as the "go to" judge mediator in her court and pretrial settlement.

conferences in the cases she presided over as trial judge. As importantly, she now has been in private practice for a year and a half and her success in developing a very busy practice with clients who worked with her both before and after she left the bench (see Paul Troy's reference in particular) confirms that she indeed was a mediator in judicial garb rather than a judge talking settlement for several years prior to starting her private practice.

But for the number of years she has been in private practice, Lisa would be a Distinguished Fellow. Under the current metrics, which of course I hope will go away soon, I nominate Lisa as a Fellow. Please let us know what you all think.

Mediation Experience

During the over 18 years that I served as a judge from 2001-2019, I became fascinated with mediating cases to resolution rather than seeing counsel and their clients gamble by going to trial. This interest was not because I disliked trials. I enjoyed the drama of trials and presided in just over a thousand trials. However, I came to see mediation as the superior method of dispute resolution as compared to having stranger jurors decide the parties' dispute. Parties saved money, time, stress and were more satisfied when they resolved the case with the help of a skilled mediator or judge and their counsel. Because of my interest in mediation, while still serving as a judge, I took 220 hours of coursework in mediation at both the National Judicial College, where I earned a professional certificate in Dispute Resolution Trial Skills, and at the Center for Understanding in Conflict. Three of the courses satisfied the requirements for state certification.

My best training though came with actually mediating cases to resolution. The cases I mediated were not cases where I was the assigned trial judge. Philadelphia is one of the highest volume state trial courts in the country being a preferred venue for many plaintiffs' attorneys with mass tort or other complex cases. To avoid a backlog, Philadelphia's Court focuses on pretrial resolution. I was selected to serve as a Team Leader based in part for my skill in getting cases resolved. For 5 years as Team Leader, I supervised a team of judges and managed trial and motion assignment of all major civil jury trials filed in a single year (inventory rose to 7,200 cases at its peak). One of the key roles of Team Leader was to preside over all pretrial conferences for all cases going to trial. These conferences inevitably became settlement conferences and consumed 75% of my time over that 5-year period. I did not conduct settlement conferences as judges typically do by exerting pressure and other means to get parties to "cave." Instead, I used my mediation training to work with lawyers and their clients to mediate cases to resolution. Before long, I gained a reputation as "the settlement judge." Lawyers with cases on other teams and judicial leadership enlisted me to resolve some of the most complex and entrenched cases. The mediation style I used was very similar to what I use now in my private mediation practice. Mediation companies recruited me to leave the bench to join their team of mediators. My final assignment as judge was solely to mediate the complex cases that would require lengthy trials because the Court was so backlogged. During my years as a trial judge and Team Leader, I mediated and facilitated resolutions in hundreds of major civil cases. Because of my passion for mediation, I chose to leave the bench early in order to pursue mediation full time. I have not been disappointed with that decision.

INTERNATIONAL ACADEMY OF MEDIATORS MEMBERSHIP CRITERIA

Overview

New IAM members will be admitted to membership in the Academy under the following guidelines:

- Membership is by invitation only
- Membership is limited to professional commercial mediators who are well established and recognized in their local or regional community as leading mediators in the field
- The IAM is dedicated to **inclusiveness** and **diversity** across a full spectrum
- The Membership and Recruiting Committees assist Academy members in identifying mediators who meet the criteria for invitation by the Board of Governors to join as **Fellows** or **Distinguished Fellows**

Criteria for Admission to Membership as Distinguished Fellow

Nominees for membership in the Academy in the **Distinguished Fellow** category must generally meet the following *minimum* qualifications with respect to mediation experience:

- in commercial mediation practice at least **5 years**, with corresponding certification for those mediators who practice in jurisdictions that have certifications for commercial mediation
- at least a majority of their professional efforts are dedicated to commercial mediation
- in developed markets, must have worked at least 600 commercial mediation days
- in emerging markets¹, must have worked at least 300 commercial mediation days
- in undeveloped markets², must have worked at least **100 commercial mediation days**
- mediation days consist of at least 4 hours of work focused on mediation of commercial disputes (including teaching, training or facilitating as well as mediating disputes and excluding days spent mediating pro bono, small claims and domestic relations matters)
- alternative mediator experience may be considered provided it is substantially equivalent (participation in mediations as party or counsel is not considered mediator experience)

Criteria for Membership as Fellow

Nominees for membership in the Academy in the **Fellow** category must generally meet the following *minimum* qualifications with respect to mediation experience:

- in commercial mediation practice at least **3 years**, with corresponding certification for those mediators who practice in jurisdictions that have certifications for commercial mediation
- at least a substantial proportion of their professional efforts are dedicated to commercial mediation
- in developed markets, must have worked at least 300 commercial mediation days
- in emerging markets, must have worked at least 150 commercial mediation days
- in undeveloped markets, must have worked at least 50 commercial mediation days

¹ "Emerging" markets are those areas or regions where relatively fewer commercial disputes are mediated, in contrast with developed markets where the majority of commercial disputes get referred to mediation, whether by courts, counsel or parties. Factors include: the extent to which mediation is mandatory, the length of time mediation has been in use, the types of disputes that go to mediation and the numbers of mediators who practice on a full or substantial-time basis.

² "Undeveloped" markets are those areas or regions where mediation is just beginning to be utilized and thus very few commercial disputes are mediated and very few mediators practice on a full or substantial-time basis.

Membership Nomination Process

Invitations to join the Academy are issued only upon **approval** by the **Board of Governors** of a **Nomination** from a qualified **Sponsor** and **Co-sponsor**

- Sponsors must be Distinguished Fellows who have been members of the IAM for at least two (2) years or who have attended at least four (4) conferences
- Nominations are submitted to the Board of Governors only from qualified Co-Sponsors on a form
 that includes attestations vouching that the prospective new member is a pre-eminent
 distinguished or rising star mediator in their local community
- Nominees for membership are encouraged to attend at least one live or virtual IAM conference at the invitation of a member (any Fellow or Distinguished Fellow may invite with approval of the Recruiting Chair) before their Sponsors submit a Nomination on their behalf.
- Mentees in the Mentorship Program who have gained the requisite experience are encouraged to seek Sponsors for nomination as Fellows

Fellows who have gained the **requisite experience** are encouraged to seek Sponsors for nomination as **Distinguished Fellows**
